1. Module Details/Results via e:Vision

This document will give you instructions as to how to switch e:Vision Module Details / Results and Progression / Award information links **ON** and **OFF** by individual student

In the past, departments have not been able to easily control whether their students can see their 'agreed' Module Details / Results and their Progression / Award information via e:Vision.

To this end, switching e:Vision access for students on/off has been further refined due to some system improvements and can now be done in academic departments on a student by student basis. This allows students on multiple courses to either see or not see their results depending upon the individual circumstances of the relevant course they are on.

If before an Assessment Committee / Exam Board period you wish to switch off the two links that are usually displayed to students, then following the instructions in this document will guide you through the process.

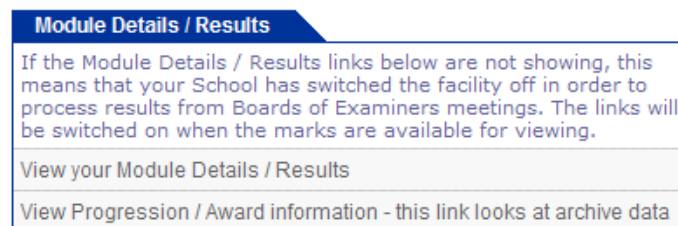


Figure 1a – the two links usually displayed in a student's e:Vision

The two links that are usually displayed in e:Vision are shown in figure 1a:

1. View your Module Details / Results
2. View Progression / Award information - this link looks at archive data

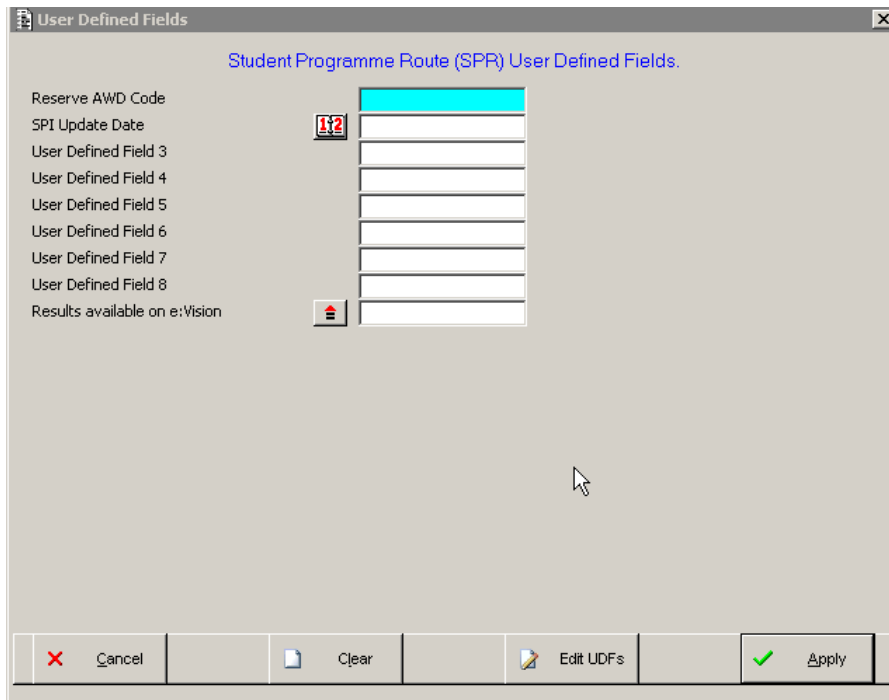


Figure 1b – the User Defined Fields on SPR. The last field (Results available on e:Vision) is now used to turn e:Vision access on/off

These links can now be switched on via the relevant students' individual Student Programme Route (SPR) record – with particular reference made to User Defined Field 9 (UDF9) – which has now been re-labelled "Results available on e:Vision" (figure 1b):

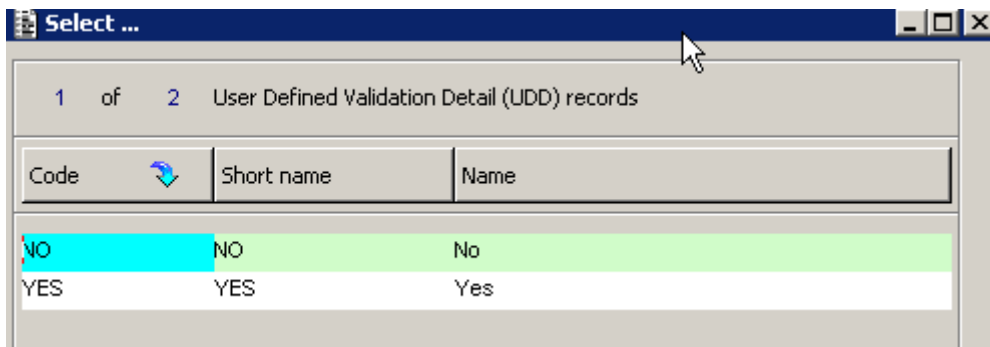


Figure 1c – the options available under ‘Results available on e:Vision’

This field can have two values: YES or NO (figure 1c).

YES indicates that the links shown in figure 1a are shown in the student’s e:Vision, and NO indicates that the links are not available.

2. Switching e:Vision links on/off – a worked example

For the following example, we will retrieve all the ACCFIN - BSc Accounting and Finance students whose 'Status' is current and their 'Study Level' is 2. Enter the search criteria into the SPR screen (figure 2a)

Figure 2a – SPR screen with search criteria entered

Entering the criteria above and selecting 'Retrieve' (or using the F5 key) will bring up the results as shown in figure 2b:

Figure 2b – results of retrieve on specified criteria

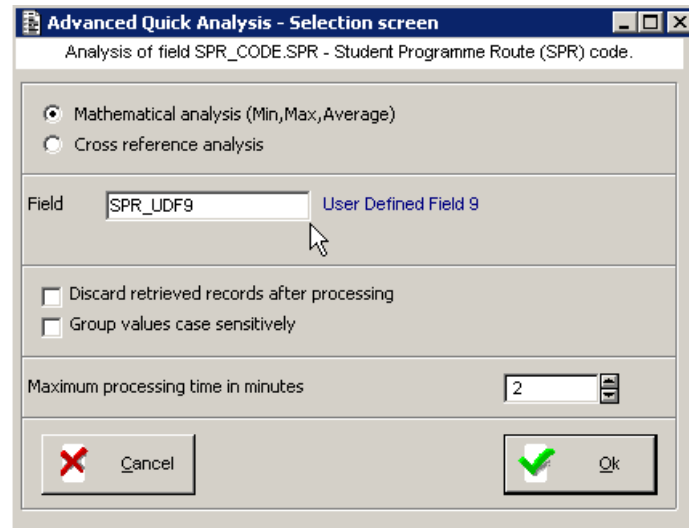


Figure 2c – how to do a quick analysis of the 'Results available on e:Vision' field

To check that the retrieved students e:Vision links are turned on, we can do a quick analysis of the 'Results available on e:Vision' user defined field (UDF). To do this, go to Misc → Quick Analysis, and enter 'SPR_UDF9' into the Field box, as shown in figure 2c. Click 'OK' to run the analysis.

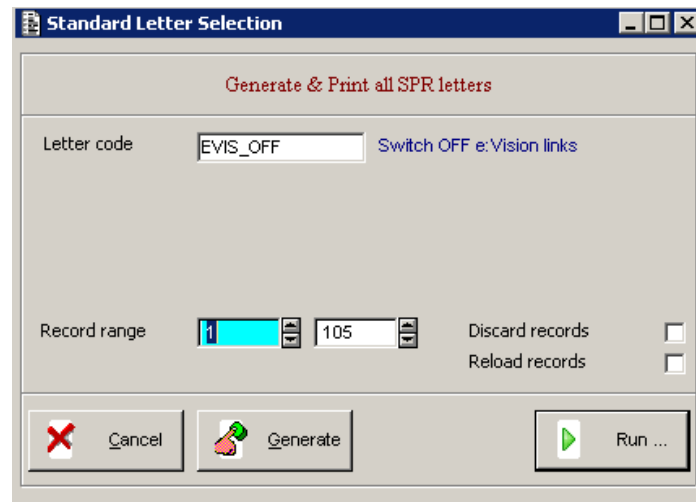


Figure 2e – running the EVIS_OFF SRL to switch off the links in e:Vision

After a few seconds, the results will appear (figure 2d). In this example, they are all currently set to 'YES', which means that the links in e:Vision are visible.

To switch the links on/off, an SRL is run from the SPR screen. The SRL codes are:

- EVIS_OFF to turn off the links in e:Vision, or
- EVIS_ON to turn the links on

The SRLs can be run against all retrieved records, by going to All → Gen + Print Letters, or against a selected record by going to Current → Gen + Print Letters. This is shown in figure 2e.

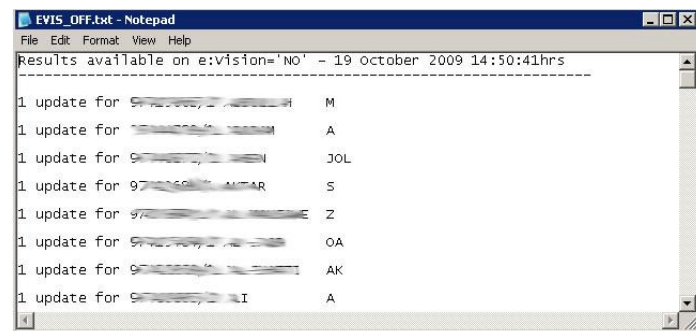


Figure 2f – the output produced when the SRL is run

The output produced is shown in figure 2f below:

If you would like to check the process has been successful, re-retrieve the same records and run the quick analysis again - this time all SPR_UDF9 fields will be set to 'NO'.

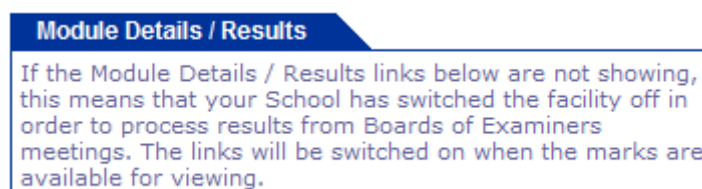


Figure 2g – student's e:Vision after the EVIS_OFF SRL has been run

The view the student will get is now displayed below (figure 2g); note that no links are visible.

To reverse the operation, when you want the links to be visible, run the SRL called EVIS_ON in the same way.

After this has been done, the student will see two links under Module Details/Results in their e:Vision, as shown in figure 2h below:

If the Module Details / Results links below are not showing, this means that your School has switched the facility off in order to process results from Boards of Examiners meetings. The links will be switched on when the marks are available for viewing.

3. Switching e:Vision links on/off – from QSU/SCE or SPI

The same facility also exists to switch the links on/off via the QSU, SCE or SPI screens. Essentially, you just run the same SRL.

EVIS_ON – to Switch ON e:Vision links

EVIS_OFF – to Switch OFF e:Vision links

Top level monitoring is best done through the SPR screen – see method to use described above in figures 2a through to 2d.
