| To provide you with an opportunity to apply the knowledge, understanding and skills gained on your taught postgraduate course in a professional setting; to help you develop autonomy and initiative, and work effectively as a member of a professional team; to help you gain experience of the working environment and assess career opportunities available on graduation; to encourage critical reflection on your personal and skills development. |

## Outline Syllabus

There is no defined syllabus and professional placements are made available by voluntary co-operation of companies and other organisations. The responsibility lies with you to identify the placement opportunity, with support from relevant parts of the University and from the Rotary International office. The placement activity must be agreed by the Rotary Centre Director and the Host Area Co-ordinator. The activities and duties whilst on placement will depend to a large extent on the particular nature of the business/profession whilst on placement. Irrespective of the nature of placement work, it is expected that on placement you will develop and demonstrate the following skills:- Communication skills (through written and verbal reports to supervisors and senior managers)- Both independent working and team working skills- Time management skills, including the ability to meet tight deadlines. The placement can be undertaken in addition to the taught programme curriculum; the placement is zero credit weighted.

## Learning, Teaching and Assessment Strategy

Placement opportunities are to be identified by you, with support from the University and agreed by the Division. The duration must be between two and three months. Your placement work is directed by the supervisor appointed by the provider, but the Rotary Centre Director will be available for consultation during the period of the Applied Field Experience.

You will evaluate your performance in a reflective end of placement report, and this will form the basis for consideration for the award of the Professional Experience component. Assessment will be made on a pass/fail basis.
