Learning, Teaching and Assessment Strategy
Lectures, workshops and, through the support of a named dissertation supervisor, individual/group tutorials are the principle means through which you will develop your understanding of a chosen topic. You are also expected to undertake in depth (empirical or literature/desk based) research in order to produce analytic and developed written work (LOs 1-5). In the formal contact sessions, you will be asked to take an active role by contributing to large and small group discussions as a means of further developing your ideas (LOs 1, 2, 5, 6). In addition, individual dissertation tutorials (with an allocated supervisor) will assist you in the development and progress of your work (LOs 1-6). Producing a dissertation enables the assessment of all learning outcomes (LOs 1-6).
