Module Aims

To provide a thorough grounding in the development of theory in archaeology and related disciplines.

Outline Syllabus

The module explores a number of key themes in archaeological interpretation, addressing the role of archaeology in the contemporary world, as well as exploring how theoretical perspectives influence interpretation. The role of the archaeologist, the use of archaeology, the display and communication of the past are all examined, as well as themes in interpretation, such as 'gender, sexuality, personhood and identity', 'can we have an archaeology of emotion?', 'new materialist understandings of the past', and 'humans, animals and the environment'. The module sets to challenge perceptions and what we think of as 'normal', including fundamental concepts such as what it is to be an individual, the construction of gendered identity, and the meaning behind objects and material culture.

Learning, Teaching and Assessment Strategy

Lectures will introduce theoretical concepts. The module is largely seminar-based, involving background reading and discussion to deepen understanding. Mini presentations will form an ongoing component of seminars to increase confidence in communicating key messages about the past and its role today, with formative assessment on presentations leading up to assessed presentation. Assessment will be through an essay and presentation. Students will undertake Directed Study for reading of literature detailed in the module documentation; and for researching and preparing for coursework. A fieldtrip at the end of the module will consolidate learning around communication of the past, public audiences, and the role of the past today (there may be a small charge towards the subsidised trip, however, we keep costs low and can provide further assistance if needed.)
