The aim of this module is to enable students, by writing a dissertation, to develop the capacity to conduct independent and advanced research under limited supervision.

Learning, Teaching and Assessment Strategy
<p>The module will include 8 hours (4 synchronous + 4 asynchronous) of interactive sessions with a lecturer. The sessions will cover preparation of the dissertation, including research methods, issues of structure etc. Ethics will play a role in this module and you will be expected to ensure that your research fulfils the ethical framework outlined in the University of Bradford's ethics policy.</p> <p>You will work with a supervisor based on your approved dissertation proposal. Students work largely on their own, and they are expected to initiate and maintain regular contact with their supervisor including the summer period. Three hours is intended to be used as contact time with the supervisor. How that time is used is a matter of agreement, but would normally involve three meetings (virtual or in person). The supervisor's role is to give guidance on the agreed dissertation proposal, provide guidance on methodology and methods as well as to provide feedback on your work as you go through the module. Therefore, consistent and early engagement with your supervisor is essential.</p> <p>Supported coursework submission encouraging the student to conduct original research.</p>
