Module Aims
<p>The aim of this blended learning module is to enable students to gain bespoke skills and competencies associated with their area of practice. They will develop an understanding of advanced practice, subject specific principles and underpinning theory for examining their client group. Clinical skills in assessment will be developed in order to undertake safe examinations amongst specified client groups, with the ability to demonstrate higher level clinical reasoning and problem solving.</p>

Outline Syllabus
<p>Case histories drawn from practice, covering a range of normal anatomy/ physiology and pathological changes. Applied pharmacology and kinetics, skill dependent equipment management and history taking. Face to face/ on line teaching materials around assessment of systematic anatomy and physiology and deviations from the norm. Problem solving and clinical decision making. Ethical, legal and professional issues around extending roles. Protocols, procedures and guidelines. Auditing of practice. Critical reading skills. Utilising research evidence to inform best practice.</p>

Learning, Teaching and Assessment Strategy
<p>Use of a blended learning approach for all delivery of teaching i.e. a mix of on-line and on-campus delivery, a mix of synchronous and asynchronous delivery will be offered, practical sessions will be delivered face to face &amp; on-campus whilst maintaining Health &amp; Safety related to current guidelines Teaching is informed by research throughout the module content, with an activities to aid develop critical thinking skills.</p> <p>Teaching materials will support learning around physiology, pathophysiology, client assessment, care pathways &amp; wider professional issues around extending roles.</p> <p>Workshops are provided by lead professionals who share expertise to develop bespoke skills.</p> <p>Timetabled face to face/online personal &amp; group tutorials will develop academic skills &amp; offer formative feedback on progress.</p> <p>There will be the opportunity to practice the OSCE assessment.</p> <p>Directed Study - relates to additional materials to aid learning. A significant part of the program is spent undertaking work-based learning activities.</p> <p>You will be supported by a nominated clinical supervisor who will be responsible for identifying key learning activities, aiding clinical skill development, reviewing clinical practice &amp; signing the student as competent.</p> <p>Clinical Practice relates to additional self-directed optional clinical opportunities that will assist learning.</p> <p>There are 3 assessment types.  An OSCE: a series of stations in examination conditions that assess LO 1.1, 1.3, 2.1, 3.1, 3.2.  Case study on a client &amp; condition or audit of your practice assessing outcomes: LO 1.1, 1.2, 2.2, 2.3.  Clinical logbook signed off by the clinical supervisor.</p>
