Module Aims
<p>This module is designed to enable students to develop a working knowledge and appreciation of the nature of criminal offences and criminal liability; to enable students to acquire a knowledge and appreciation of the major criminal offences (to include sexual offences, non-fatal offences against the person, homicide and property offences); and to enable students to acquire skills in critically evaluating contemporary criminal law and proposals for reform.</p>

Outline Syllabus
<p>The module is broadly split into two halves. For the first half of the module students will study the theory of criminal law. Principally this includes the concepts of criminalisation, and the construction of offences and defences. Students will then go on to apply this theoretical framework to a range of substantive offences: sexual offences, non-fatal offences against the person, homicide (including murder, and voluntary and involuntary manslaughter), and property offences (including theft, burglary, and fraud).</p>

Learning, Teaching and Assessment Strategy
<p>Your learning will be directed, supported and reinforced through a combination of lectures, tutorials and guided private study. Lectures will introduce and explain key concepts and principles. In tutorials you will learn how to apply statutes and cases appropriate to the different elements of the syllabus through a variety of questions and a range of directed reading. All learning outcomes will be addressed through the tutorial work to prepare students for the assessments.</p> <p>The tutorials are broken down into weekly tasks designed to allow and encourage you to demonstrate your achievement of the learning outcomes in different formats, thus broadening your skills and fostering a more inclusive curriculum.</p> <p>All teaching and learning is supported by information (including the module handbook) provided on Canvas, our virtual learning environment.</p> <p>Summative assessment will consist of a written assignment and an unseen examination. The written assignment, at the end of semester 1 will test all learning outcomes. The examination at the end of semester 2 will test LOs 1,2,3. For the formative assessment, all students will be provided with past coursework and exam questions. Students will be invited to submit essays for any of the questions which they would like to answer. Students will then receive constructive feedback on the answers provided.</p>
