Learning, Teaching and Assessment Strategy

The work based project will be utilised to inform the Clinical Practice Change report and presentation.

Academic Support will be provided by the same supervisor as work based project.

Open book exam will assess L1, Clinical practice report will assess L2 and Presentation will assess L3
