Module Aims
<p>This module aims to:</p> <ul style="list-style-type: none"> - Provide a critical awareness of key themes, trends, and debates in the field of global migration and migration policy; - Provide a range of theoretical perspectives on migration as a global issue, and its relationship with social policy, welfare, social integration, development, human rights, and international politics; - Develop students' ability to apply critical perspectives and research evidence in the analysis of global issues, challenges, and social policies; - Develop students' ability to critically engage with knowledge production processes and methodological debates in the field of migration research.

Outline Syllabus
<p>The students will be introduced to a diverse range of topics related to the study of global migration: conceptualizing migration, and globalization; why people migrate: macro-level explanations; meso-level explanations; micro-level explanations; migration regimes, governance and citizenship; migration-development nexus; gender and migration; forced migration and refugees; irregular migration, violence and border securitization; human trafficking and smuggling; bodies, sexuality and health; displacement and humanitarian governance; social integration, inclusion and welfare policy; racialization, othering, and multiculturalism; the politics of migration in contemporary Europe.</p>

Learning, Teaching and Assessment Strategy
<p>Lectures and seminar discussions. The lectures will introduce a range of related subjects in this area, together with advice and direction for reading to be conducted during Directed Study periods. The seminar sessions will provide opportunities to deepen learning and develop discussion skills through group interaction. Each week students will review empirical studies on the assigned topic for class discussion and they participate in learning activities designed with a problem-based, active learning approach.</p> <p>The presentations assess LO 4-6 and allow students to develop critical skills and receive feedback in advance of their final assessment. The report assesses all LO and is designed to allow students to choose an area for analysis of a migration-related topic from a global social policy perspective.</p>
